Supplementary information to the Price List:

1. Short-term accommodation means accommodation for a period of less than 3 months. The price of short-term accommodation includes 10% VAT.
2. The prices for long-term accommodation are without VAT.
3. The accommodation price is always paid for the entire calendar month of accommodation, regardless of the actual number of days of accommodation in a given calendar month.
4. When concluding the accommodation contract, the total amount of the accommodation price is in addition to the fees based on generally binding legislation (e.g. Act No. 582/2004 Coll. on Local Taxes and Local Fees for Municipal Waste and Small Construction Waste) and generally binding regulations of the city or municipal district in which the accommodation facility is located.
5. The provision of accommodation to non-students is at the discretion of the Director of Student Houses.
