The prices listed in this Price List may be adjusted by the inflation index in accordance with the internal regulation of the CU, which determines the rules for fixing accommodation prices in the accommodation facilities of the Comenius University Bratislava.

Supplementary information to the Price List:

1. According to the internal regulation of the CU, which determines the rules for fixing accommodation prices in the accommodation facilities of the Comenius University Bratislava, this Price List applies to temporary accommodation during the months of September to June for:

- a) full-time students of the CU faculties,
- b) full-time students of public higher education institutions and state higher education institutions in Slovakia
- c) government scholarship holders.

2. The Price List also applies to temporary accommodation during the months of July and August for:

- a) full-time third-level students at the CU faculties,
- b) students of the CU faculties whose study programme includes the implementation of internship during the above-mentioned months,
- c) students of the CU faculties who pass the state examination or the final thesis defence during the above-mentioned months,
- d) students of the CU faculties who have been granted a social scholarship for the above-mentioned months.

If the duration of the internship of students of the CU faculties under (b) is less than 4 weeks, the accommodation price is adjusted (reduced) in proportion to the number of weeks of the internship.

3. The accommodation prices in this Price List also apply to students studying at the CU faculties within the framework of foreign academic mobility.

4. The accommodation prices are exclusive of value added tax.

5. When concluding the accommodation contract, the total amount of the accommodation price shall be in addition to the fees based on generally binding legislation (e.g. Act No. 582/2004 Coll. on Local Taxes and Local Fees for Municipal Waste and Small Construction Waste) and generally binding ordinances of the city or municipal district in which the accommodation facility is located.

This Price List was discussed at the meeting of the Management Board of Comenius University Bratislava on 15 June 2023 and at the meeting of the Commission for University Dormitories and Accommodation of the Academic Senate of Comenius University Bratislava on 19 June 2023.
