Your data will be made available to the members of the election commission, the staff of the CU Academic Senate and the members of the CU Academic Senate. Your data as provided in this nomination will also be published on the website of CU and in the official bulletin of CU.

We process your data **in order to ensure compliance with our legal obligations** under Art. 6(1)(c) of the GDPR* and to **carry out tasks in the public interest** under Art.6(1)(e) of the GDPR. You are not allowed to nominate a candidate for the Rector or run for the Rector yourself unless you give us consent to process your data.

According to Article 21 of the GDPR, you have the right to object at any time to the public interests we pursue.

We also process your personal data for the purpose of carrying out tasks in the public interest. However, you have the right to object to this goal (public interest) at any time.

If you choose to object, CU may no longer process your personal data, unless it can demonstrate that its compelling legitimate interest overrides the interests or the fundamental rights and freedoms of you, the data subject.
