

## *Outline of the description of the habilitation and inauguration proceedings*

**Contents definition:** Paediatrics represents the specialization medicine division, which content in the pre-gradual preparation of the doctors consists of two mandatory subjects – paediatric propaedeutics and paediatrics. Paediatrics analyses from theoretical and practical point of view the problematics of healthy and sick child from the birth till the 18th year of life + 364 days. It incorporates the theoretical knowledge and practical diagnostics, differential diagnostics, treatment and prevention of the diseases of childhood, appraisal and research activity, which all in the praxis together with the further and continual education allow the quality general and specialized healthcare in the paediatrics – in both outpatient and hospital form.

Extent of theoretical knowledge, practical skills and experience contain physiologic developmental processes and their variations, basics of anatomical and functional prenatal development, assessment of the new-born status, postnatal adaptation and preventive screening programs. It reflects the growth with the changes of body composition, psychomotor, cognitive and social development of the child in the particular age categories, its variations and impact of the genetic and environmental factors. It places importance on the behavioural aspects and sexuality, child behaviour, emotional development and its most frequent disturbances.

Knowledge extent handles also the care for the healthy child development, its body functions, sleep, new-born specificities, premature babies with low-birth weight, psychosocial care, acute and chronic ill child. It touches also the physiology of the nutrition and feeding in health but also in acute and chronic diseases.

In the spectrum of knowledge there is also the preventive and social paediatrics, paediatric psychology, immunization, hygienic problematics of healthy and sick children, factors of social environment, sudden infant death syndrome, early recognition of the developmental disturbances and severe diseases, prevention of the injuries and intoxications, and interdisciplinary team-work with sick child. It places the importance on the rights of hospitalized child, right of the handicapped persons, rights and duties of the child's legal representative, specificities of the professional communication with the infant patients and its legal representative.

A specific area of paediatrics is represented by the violence on the child in every its forms – signs, diagnostics and identification, physical and psychological convalescence, social re-integration of the abused child together with the particular state authorities and also the interventional programs corresponding to the particular developmental needs of the children and adolescents which committed the crime.

Basic paediatric diagnostic and therapeutic procedures contain anamnesis analysis, physical examination, laboratory methods and imaging techniques, differential diagnostics in the emergency situations, neonatal problematics, inherited developmental errors, disturbances of nutrition, malabsorption, liver diseases, respiratory diseases (including cystic fibrosis, bronchial hyperreactivity, sleep medicine), congenital and acquired defect of heart and vessels, immunodeficiencies, immunopathological reactions, allergies, atopy, rheumatic diseases, disorders of blood (including anaemias and coagulation defects), genetic disorders, malformation syndromes, malign and benign tumours, urogenital system diseases, neurological diseases, diseases of muscles, bones and joints, endocrinological disease (including diabetes mellitus and growth disturbances), inborn errors of metabolism, infectious diseases, parasitic diseases, inflammatory and non-inflammatory skin diseases, basics of physiotherapy, psychological and psychosomatic diseases, sleep disturbances, adolescent medicine (including the problematics of maturation and sexuality) and appraisal activities.
